Child Protection Policy

The School operates the following policy on its website regarding the use of photographs, to ensure the privacy and safety of pupils at the school:

- Parental permission to use photographs of children on the website, Twitter and for any other school-related publicity will be sought when a child first joins the school; staff members will be made aware of children who have not been granted such permission and those children will not feature prominently in any online photographs (although may appear in some photographs if not easily identifiable, e.g. whole school events).
- Photos of children may be used to show them learning, working, playing or representing the school. When choosing photographs to be used on the website, Twitter or in other school-related publicity, the school will be mindful of the way pupils may appear in them, and will not include images which are in any way inappropriate.
- Where pupils are named, no surnames will be used.

Website Privacy Policy

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

(1) What information do we collect?

We may collect, store and use the following kinds of personal data:

1. Information about your visits to and use of this website;
2. Information about any transactions / communication carried out between you and us on or in relation to this website;
3. Information that you provide to us for the purpose of registering with us and/or leaving comments and/or subscribing to our website services and/or email notifications.

(2) Information about website visits

We may collect information about your computer and your visits to this website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views. We use cookies on this website. A cookie is a text file sent by a web server to a web browser, and stored by the browser. The text file is then sent back to the server each time the browser requests a page from the server. This enables the web server to identify and track the web browser.

We may send a cookie which may be stored by your browser on your computer's hard drive. We may use the information we obtain from the cookie in the administration of this website, to improve the website's usability and for marketing purposes. We may also use that information to recognise your computer when you visit our website, and to personalise our website for you.

Most browsers allow you to refuse to accept cookies. (For example, in Internet Explorer you can refuse all cookie by clicking "Tools", "Internet Options", "Privacy", and selecting "Block all cookies" using the sliding selector.) This will, however, have a negative impact upon the usability of many websites.

(3) Using your personal data

4. Except as provided in this privacy policy, we will not provide your information to third parties.

(5) Security of your personal data

We will take reasonable precautions to prevent the loss, misuse or alteration of your personal information. Of course, data transmission over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.
